

7IM's investment process

At 7IM, we have a strong and clear set of investment principles. We believe in them, refer to them often, and are confident that they'll help us to safeguard our clients' assets and deliver healthy returns over the long term. They've been in place for two decades now and haven't changed.

The starting point for all of our multi-asset portfolios is our tried and tested strategic asset allocation which provides a robust framework for each model portfolio.

Philosophy

7IM's range of Model Portfolios

7IM Active Model Portfolios

This tactical asset allocation is implemented predominately through active funds although passive instruments may be used as and when required.

7IM Blended Model Portfolios

The tactical asset allocation is implemented through a range of passive and smart passive instruments including tracker funds and exchange traded funds (ETFs), because of their low cost and high liquidity as well as some active instruments.

7IM Passive Model Portfolios

The portfolios use a streamlined SAA which is implemented using investments that are transparent and cost effective, typically exchange traded funds and index tracker funds.
